The Community Center field will be open by 8 AM.

A 10' x 20' tent (two spaces) will be provided for every two vendors. You will need to supply your table, chairs, and table clothes. No electricity will be available. This is an outdoor event. Port-a-Jons and event concessions will be available. All vendors are responsible for their space and are requested to leave their area clean and free of trash or debris upon departure. Trash receptacles are provided on site.
